#### Note:

For any engagement, Kenya Vision 2030 Delivery Secretariat shall require all drivers to be professional, experienced, possess a certificate of good conduct and well-groomed at all times.

### e) Category B7 -Provision of Hotel Accommodation and Conference Facility

The Hotels should state their geographical locations and be (4) star rated and above in Mombasa, Lamu, Malindi, Machakos, Nairobi, Embu, Nyeri, Nanyuki, Naivasha, Nakuru, Eldoret, Kakamega and Kisumu. (Hotels in other towns other than the ones mentioned can apply and be considered based on provision of quality standards)

Kenya Vision2030 Delivery Secretariat may undertake an inspection visit to the hotels that
have applied with view to conducting due diligence on the facilities and establish whether
they meet the quality standards.

#### f) Category B15, Air travel agents

Firms must provide proof of membership with **IATA**. The firms should demonstrate that they have 24 hour dedicated personnel/call line to cater for emergency requirements.

#### g) Category B20 Legal services

Advocates must be in good standing with valid practicing license from LSK.
